8. In case of any dispute arising out of this agreement the same shall, as far as possible, be settled between the parties by mutual negotiations. Where such negotiations fail, the dispute shall be referred to arbitration in provisions of the Arbitration and dispute resolution Act.

The standard Force majeure clause shall be applicable to this agreement.

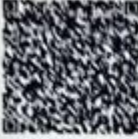
