- 2. The Common Bio Medical Waste Treatment Facility will collect the segregated Bio Medical Waste.
- 3. Treatment Facility will collect the segregated Bio Medical Waste from the identified locations at the hospital.
- 4. Segregated waste will be transported in closed container Vehicle to the CBWTF.
- 5. Appropriate treatment and or shredding of segregated waste will be undertaken at the centralized facility as per Schedule 1 of the rules.
- 6. Complete disposal of Biomedical waste, Testing of treated wastes etc. to ensure safety to the environment will also be done at the common facility.
- 7. The collected waste material sent by the hospital may be checked and suggestions may be given for improvement in the segregation of the waste.
